The future of jobs now stands at a crucial juncture with a major transformation underway as companies shift to a digital workspace and use advanced tools and technology to communicate, collaborate and innovate. While the present situation offers many opportunities that could positively impact sectors such as healthcare and finance, several challenges also arise, especially in terms of skilling and reskilling the workforce for sustaining current and future jobs, as qualities of jobs change and companies consider a more futuristic way of working.
